## **Southern Illinois Christian Service Camp Statement of Faith, What we Believe**

- † We adhere to a conservative interpretation of the Bible and to the tenants of the New Testament Restoration Church.
- † We believe that God is one being in three persons, God the father, God the son, God the Holy Spirit. (1 Tim 2:5; Matthew 3:16-17)
- † We believe that in the beginning was God, He was here from the beginning of time and will be to the end, He is an everlasting God. (Colossians 1:15-17; Rev 1:8, Rev. 22:13)
- † We believe that in the beginning He Created all things and continues to work in and through us. (Genesis 1:1; John 1:1-2; Colossians 1:15-17)
- † We believe the Bible as the only inspired Word of God. (2 Tim 3:14-17; 2 Peter 1:16-21)
- † We accept that all miracles in both the Old and New Testament as having actually occurred. (Romans 10:17; 2 Tim 3:16; Hebrews 11:1)
- † We believe in the in the miraculous conception and birth of Jesus Christ by the virgin Mary. (Matthew 1:18-25; Luke 1:26-38)
- † We believe that Jesus is the incarnation of God the Son and the Word became flesh (Johnn1:14; and He now holds all authority in heaven and on earth. (Matthew 28:18)
- † We believe that Jesus is the Christ the only begotten Son of God, (John 3:16; 1 John 4:9) and that he is the Way, the Truth, and the Life and that no man comes to the Father except through Him. (John 14:6)
- † We believe that Jesus Christ is the Savior of the world, (John 4:42; Acts 5:31; 1Tim 4:10) that he was crucified, buried and arose on the third day from the dead. (Mark 16:6; Luke 24:7) He is now alive and seated at the right hand of God. (Luke 22:69; Eph 1:20; Col 3:1)
- † We believe the Holy Spirit is active and convicts' people of their sin, righteousness and the judgement to come. (John 16:5-11)
- † We believe the Lord's Supper is the celebration of the New Covenant, in which the Christian community remembers Christ and celebrates the covenantal relationship they have with Him and with each other. Congregations in this fellowship typically celebrate the Lord's Supper at least weekly (1 Corinthians 11:17-34; Acts 20:7)
- † We believe God created man and woman and defined our sex at conception. Genesis 1:26-27; Ps 139:13-16)
- † We believe that marriage is defined as one man being united with one woman, in Holy matrimony before God. (Gen 2:18-25; Matthew 19:5-6; Hebrews 13:4) That marriage was established by God to be a lifelong, exclusive relationship between one man and one woman and that all sexual activity outside of the marriage relationship, whether heterosexual, homosexual, or otherwise is immoral and therefore sin. (Gen 2:24-25; Exodus 20:14, 17, 22:19; Lev 18:22-23, 20:13, 15-16; Matt19:4-6, 9; Romans 1:18-31; 1 Corinthians 5:9-10, 15-20; 1 Tim 1:8-11; Jude 7).
- † We believe sexual intimacy is to be between a man and a woman who are married to each one another. (1 Corinthians 6:18; 7:2-5; Hebrews 13:4)
- † We believe in the sanctity of all human life, from the time of conception, till natural death. Genesis 9:5-6; Exodus 20:13; Psalms 139:13-16
- † We believe that all human beings were created by God to have fellowship with Him (1 Corinthians 1:9; Ephesians 2:4-6) However, Everyone (except Jesus), have sinned and fallen short of the Glory of God (Romans 3:23), But, God has given us a free gift (if we are willing to accept it) of grace and forgiveness (Romans 6:23)

- † We believe that any form of sexual immorality (including adultery, fornication, homosexual behavior, bisexual conduct, bestiality, incest, or any attempt to change one's sex or disagree with one's biological sex) is sinful and offensive to God. Matthew 15:18-20; 1 Corinthians 6:9-10)
- † We believe that salvation comes from believing (faith) (Acts 16:30-31; Romans 10:13-17; Mark 16:16), repentance (2 Corinthians 7:9-10; Acts 2:38), confession (Romans 10:9-10; Matthew 10:32) and immersion (baptism) (Acts 2:38; Acts 8:35-39; John 3:23; Romans 6:3-9; Acts 13:33) are the only divinely appointed means of accepting Christ and entering His Church.
- † We believe that outside of Christ, God has not promised salvation. (Acts 4:12)
- † We believe that Christianity is a way of life, It is founded on Christ, (1 Corinthians 3:10-12; Mathew 16:18; Acts 20:32 Based on doctrine (Hebrews 6:1-2; 1 Corinthians 15:1-4), designed for all (Colossians 3:11; Philippians 2:10-11), centers on salvation (See salvation above), and produces changes (Matthew 16:24-27; Ephesians 4:17) on how one lives their life.
- † We believe the final coming of our Lord Jesus Christ is a time when Christ will return in all of His glory as Savior and Judge of all the world. At that time, there will be a bodily resurrection of the dead; where believers in Christ will receive eternal life with God and unbelievers to eternal judgement and death. ( 1 Thessalonians 4:16-17; Revelation 20:11-15).
- † We believe that in order to preserve the function and integrity of Southern Illinois Christian Service Camp, Society, (SICSC), and to provide a biblical role model to those who participate in the ministry of SICSC, it is imperative that the directorate of the camp, all persons employed by SICSC in any capacity, or who serve as volunteers, and any and all rental groups, agree to subscribe, without reservation, to this Statement of Faith of what we believe. (Matthew 5:16; Philippians 2:14-16; 1 Thessalonians 5:22)

#### Code of Conduct for Faculty

1. I will display a Christian conduct and attitude at all times.
2. I will park the vehicle I drive in the parking area by the playground.
3. With regard to clothing – modesty must prevail at all times. If my style of dress is considered inappropriate, I will be asked to change. Suggestive slogans on clothing are prohibited. No bare midriffs
4. I will report all sickness and injury to the Dean and / or Camp Manager.
5. I will not let visitors interfere with the camp schedule.
6. I will plan to worship (personal/corporate).
7. I will not use or promote the use of illegal drugs, marijuana, vaping material, alcoholic or tobacco products.
8. I will avoid words, phrases and stories, which may compromise my Christian witness.
9. I will keep myself sexually pure.
10. I will be careful in touching or hugging campers, faculty, or staff to avoid misunderstanding.
11. I recognize that my Christian witness is needed at all times on and off duty.
12. I will avoid situations, which may cause a fellow Christian to fall into temptation.
13. Each person is valuable to God; therefore, I will treat them with dignity and respect.
14. Praying and supporting those in authority over me is my Christian responsibility.
15. I realize what I say, where I go, what I listen to, what I read, what movies and videos I watch, how I spend my time, how I treat others, and what I wear all have direct bearing on my Christian witness.
16. I will follow and honor camp policies and Statement of Faith.

Faculty failing to respond to authority of camp personnel, or the above code of conduct will result first in a verbal warning. The second warning will be written, the third warning will result is a discussion concerning dismissal. If caught stealing or pilfering through others belongings *will be immediate dismissal*. Unacceptable behavior will not be tolerated. Any act deemed unacceptable will result in dismissal. Southern Illinois Christian Service Camp will not allow one person to ruin a good camping or work experience for others.
